## CONDITIONS OF USE

1. This form is valid for five years from the date of signing. The consent will automatically expire after this time.
2. We will not re-use any images after this time.
3. We will not include details or full names (which means first name and surname) of any young adult in an image on video, on our website, or in printed publications, without good reason. For example, we may include the full name of a competition prize winner if we have their consent. However, we will not include the full name of a model used in promotional literature.
4. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video or on our website or in printed publications.
5. If we use images of individual young adults, we will not use the name of that person in the accompanying text or photo caption without good reason. And if a young adult is named in the text, we will not use a photograph of that person to accompany the article without good reason. For example, we may include a picture and full name of a competition prize winner if we have their consent. However, we will not include a picture and full name of a model used in promotional literature.
6. We may use group or activity images with very general labels, such as 'a fantastic horticulture session' or 'making Christmas decorations'.
7. We will only use images of members who are suitably dressed, to reduce the risk of such images being used inappropriately.
